



## LIMITED WARRANTY

However, in the event there is a problem with the product you have purchased, Bear Bones Systems extends to you the following Limited Warranty.

Bear Bones Systems LLC, hereby warrants to the original retail purchaser that the product produced by Bear Bones Systems LLC and operated by the original purchaser will be free from defects in material and workmanship for a period of one or three years following the original retail purchase subject to the requirements, exclusions and limitations stated below. If the product is rented or used for commercial applications, the Warranty is null and void.

### THREE YEAR LIMITED WARRANTY

Subject to the requirements, exclusions and limitations stated below, the structure of your Bear Bones Systems LLC product is warranted to the original retail purchaser against defects in materials and workmanship arising from normal use for (3) years from original retail purchase date and is limited to the structural components and their welds.

### ONE YEAR LIMITED WARRANTY

Subject to the requirements, exclusions and limitations stated below, all other components of your Bear Bones Systems product are warranted to the original retail purchaser against defects in materials and workmanship by Bear Bones Systems LLC arising from normal use for one year from original retail purchase date.

### EXCLUSIONS TO THE ABOVE LIMITED WARRANTY

- Tow Vehicle Wiring, Tow Vehicle Wear, Damages to any Tow Vehicle, and Damages to any cargo.
- Damages or wear caused by unreasonable use or failure to perform repairs and or maintenance.
